The corridors being developed under RRTS Phase-1 are **Delhi-Ghaziabad-Meerut**, **Delhi-Gurugram-SNB-Alwar** and **Delhi-Panipat**. Once operational, RRTS will be the fastest, the most comfortable and the safest mode of travel in the NCR.

These projects will not only provide a vital new transport infrastructure backbone to the region but also act as a catalyst for development of sub urban centers, providing jobs in the Indian economy and relieving congestion in main cities through faster reliable connections.
