APPOINTMENT OF DIRECTOR (PROJECTS)

1. COMPANY PROFILE

NCRTC is a 50:50 Joint Ownership Company of the Government of India (GoI) and State Governments of Uttar Pradesh, Rajasthan, Haryana and NCT of Delhi with the following funding pattern:

Central Government

Ministry of Housing & Urban Affairs : 22.5% Ministry of Railways : 22.5% National Capital Region Planning Board : 5.0% **State Government**

Government of NCT Delhi : 12.5% Government of Haryana : 12.5% Government of Rajasthan : 12.5% Government of UP : 12.5%

The Corporation is at par with Schedule 'A' Central PSU and has been set up as a company under 'The Companies Act, 1956' for taking-up design, construction, operation & maintenance of Regional Rapid Transit System (RRTS) project for National Capital Region. Its Registered and Corporate office is at the following address – Gati Shakti Bhawan, INA, New Delhi -110023

As per the Regional Transit Plan, total of 8-RRTS corridors have been identified out of which 3-corridors, namely, Delhi-Alwar, Delhi-Panipat and Delhi-Meerut have been prioritized for implementation. The Delhi-Meerut corridor section (Rs.30,274 Cr.) was sanctioned by the Government of India in 2019 and the 42 kms. section from Sahibabd to Meerut South has been opened for commercial operations.

The authorized share and paid-up capital of the Corporation is Rs.100 Crore as on 31st March, 2024.

2. JOB DESCRIPTION AND RESPONSIBILITIES:

Director (Projects) is a member of Board of Directors and reports to the Managing Director. He/She will be responsible for planning and formulating policies relating to design and architecture, tendering, contracting and overall project administration, supervision of construction sites and commissioning of RRTS projects in NCR. He/She will also be responsible for project monitoring, interface management, quality assurance, safety at the construction sites, cost control, land acquisition, rehabilitation of project affected persons/businesses, utility and traffic diversions etc. required for construction work. He/She shall be responsible for planning next phases of RRTS as mandated by the Government.

6. UNDERTKING BY THE APPLICANT/ CANDIDATE:
