FILLING-UP OF THE POST OF GROUP GENERAL MANAGER (OPERATIONS) ON DEPUTATION BASIS

National Capital Region Transport Corporation (NCRTC) – a Joint Venture of Govt of India and States of Delhi, Haryana, Rajasthan and U.P, under the administrative control of Ministry of Housing and Urban Affairs, is mandated for implementing the Regional Rapid Transit System (RRTS) in National Capital Region(NCR), ensuring a balanced and sustainable urban development through better connectivity and access. The RRTS will be a new, dedicated, high speed, rail based, high capacity, comfortable state of art, world class commuter service connecting regional nodes in NCR. It will provide reliable, high frequency, point to point and safe regional travel at high speed along dedicated pathway for relatively longer distance with fewer stops and at higher speed.

The technology chosen would allow covering distances of 100 km. in an hour with scheduled stoppages. The system would also ensure the convenience of quality last mile connectivity, addressing the needs of all categories of travelers on the network. The corridors being developed under RRTS Phase-1 are **Delhi- Ghaziabad-Meerut**, **Delhi- Gurugram- SNB- Alwar** and **Delhi- Panipat**. Once operational, RRTS will be the fastest, the most comfortable and the safest mode of travel in the NCR.

These projects will not only provide a vital new transport infrastructure backbone to the region but also act as a catalyst for development of sub urban centers, providing jobs in the Indian economy and relieving congestion in main cities through faster reliable connections. This high profile project with high performing teams offers a once in a lifetime opportunity to make a significant and lasting contribution to the life of NCR and the country as a whole. The diversity of individuals and skills we require to complete this task is simply huge. Further, the learning opportunities in an organization that is at its inflexion point of initiating some of the largest infrastructure projects in this country will be immense. In the coming months, NCRTC will be going to start train operations on the priority section of Delhi-Ghaziabad-Meerut Corridor. PHYSICAL & MEDICAL FITNESS-

The applicant should not only be suitable in related field, but also should be physically and medically fit enough.

SELECTION PROCESS-

Officers will be shortlisted, based on their eligibility/ experience in the relevant field and may be called for interaction to assess suitability for the job.

TERM OF DEPUTATION- Normal term of deputation, but the period of deputation will in no case exceed 07 (Seven) years.

PERKS, BENEFITS & POSTING:

The pay and allowances for deputation shall be regulated as per the DOPT rules. In addition, the Corporation offers Lease, Transport, Medical, Laptop/ Mobile handset/ Electricity/ Phone charges, subject to limits and other allowances as per Company's policy. The job is transferable, and the selected candidates can be posted/ transferred to any of the office/ work- place of NCRTC during the course of their service.

RESIDENTIAL ACCOMMODATION- NCRTC will be providing company/ Leased Accommodation as per entitlement to the officer who joins NCRTC on deputation. Officers occupying GPRA will be governed in terms of MoUD's letter No. O.M. No. 12035/14/92-Pol.II dated 11.10.2000.

EXEMPTION FROM THE RULE OF PERMANENT ABSORPTION- DoPT vide its OM No. AB.14017/86/2007-Estt. (RR) dated 16.01.2008 has granted exemption for deputationist Officers joining Joint Sector companies, set up for Metro Projects, from the rule of permanent absorption so long as they are in "construction mode". MoHUA has extended these instructions for NCRTC also vide its letter No. K-14011/17/2016-MRTC-1dated 03.01.2017.
