#### Following Certificates/ Documents will be verified in original: -

- (i) Matriculation Certificate- For verification of Date of Birth. This certificate must be issued by Recognised/ approved Govt. Institute.
  - (ii) Qualification Certificate- For verification of qualification. This certificate must be issued by Recognised/ approves Govt. Institute. Qualification attained through distance mode shall not be considered.
  - (iii) SC/ST/OBC/EWS Certificate as applicable, in the prescribed format and issued by appropriate authority. In case of OBC/EWS Certificate, should be current (not more than one year old) and should have clause of non-creamy layer. Formats of OBC and EWS Certificates are available on NCRTC website.
  - (iv) One photocopy set of all documents, duly self-attested.
  - (v) Ten latest and clear passport size photographs.
1. After verification of documents, eligible candidates will be directed to NCRTC nominated hospital for medical examination and will be required to report in the hospital on next day. Candidates have to undergo medical examination as per the **IRMM- Medical Standard**.
  2. Calling of candidates for documents verification does not automatically confer any right upon candidate for his medical examination or appointment in NCRTC.
  3. In case any candidate has appeared through proxy, strict action as per law will be taken.
  4. Candidates will be paid travel expenses of Indian Rail, Sleeper Class base fare on production of copies of onward/ return journey tickets.
  5. Candidates are advised to come with preparation for 3-4 days stay in Delhi at own arrangement. The successful candidates will have to join immediately after clearing the medical examination.
  6. While reporting for documents verification, candidate will come with face mask. Without mask entry in NCRTC premise shall not be permitted.
  7. In case, any candidate suffering from COVID-19 infection, he is not required to report, instead he will inform through e-mail along with scanned copy of his COVID-19 positive report. In such case further date will be allotted to her/him after a substantial time to get recovery.
- **Since the requirement is urgent and it is expected that shortlisted candidates will report in time. In case of non-reporting of a candidate, it will be considered his/her unwilling for the job and next candidate in the list will be called for the subject process. No request for postponement of schedule etc. shall be entertained.**
